## Children in Between

Classes use the **Parents' and Children's GUIDEBOOK 6<sup>th</sup> Edition**.

Children in Between is an Educational Intervention Service for Divorcing Families. It is approved by the ***Iowa Court of Law Fifth Judicial District and the Second Judicial District*** for the required 240 minutes of completed coursework. Children in Between signifies that this takes place by in-person attendance and all documentation is completed for verification. *On-line courses designated as Children in the Middle are not accepted in the State of Iowa Judicial System.* Children in Between is also recognized by SAMHSA'S Registry of Evidenced-based and Promising Practices Programs.
